## **WINDOW COVERINGS INDUSTRY ANNOUNCES CALL FOR ENTRIES FOR 32<sup>nd</sup> ANNUAL PRODUCT AWARDS COMPETITION**

**New York, NY (January 5, 2023)** - The **Window Covering Manufacturers Association (WCMA)** announced its call for entries for the **32<sup>nd</sup> annual WCMA Product Awards competition**. This year's awards will be held in person. Product submissions will be judged in the following product categories: cellular and pleated shades, drapery hardware, green products, horizontal blinds, motorization and automation, Roman and roller shades, shadings/sheers, shutters, specialty applications, miscellaneous products, and verticals/panel tracks.

**The WCMA Product Awards competition** will honor manufacturers for design ingenuity, attention-grabbing styles, and technical advancements of their 2022 window-covering products and for the past year's standout marketing programs and services.

Nominated products will be reviewed for innovation, aesthetic appeal, creativity, quality, practicality, and marketability by a panel of industry experts. Window coverings manufacturers are eligible for awards for their marketing and merchandising programs, selected by the judges for their execution and their achievements.

The *WCMA Product of the Year* is awarded to the window covering product, selected from any category, for its standout design, style, and technical innovation. All manufacturers and suppliers of window covering products in the United States and Canada are encouraged to submit products and marketing programs introduced to the market and available to consumers between December 31, 2021 and December 31, 2022 for consideration.

The 2022 WCMA Product Awards winners will be announced at the IWCE show this Spring.

video showcasing the product. The deadline for submitting nominations online for the 2022 WCMA Product Awards is **January 31, 2023**.
