MANUFACTURER MEMBERS: Manufacturer Membership shall be limited to any firm, partnership, corporation or other organization actually engaged, immediately prior to application for membership, in the business of manufacturing or assembling interior or exterior window coverings, a portion of which manufacturing or assembling is performed within the continental United States or Canada.

FABRICATOR MEMBERS: Fabricator Membership shall be limited to any firm, partnership, corporation or other organization not eligible for membership in the Manufacturers Division that is actually engaged, immediately prior to the application for membership, in the business of fabricating or assembly of interior or exterior window coverings, a portion of which fabricating is performed within the continental United States or Canada.

MANUFACTURER AND FABRICATOR MEMBER DUES BASED ON ANNUAL SALES/REVENUE

For the **MANUFACTURER** and **FABRICATOR MEMBERS** of **WCMA**, yearly dues are based on a six-step sliding scale of member company gross annual sales or revenue. Companies should calculate their dues category on the basis of sales for the most recent fiscal year.
